Role Overview and Core Responsibilities:

- You should expect 50% of your time to be on site with the full analysis team which can mean travelling Sunday night and travelling home Friday early afternoon

Salary and Reward Details

Basic salary of £70k - £89k per annum (dependent on experience) plus expected commission uncapped in excess of £30k.
